Thank you for inquiring about the Financial Aid (FA) Program at Hale. We have established a fund to help families with the cost of tuition for our programs. It is our intent to make adequate financial arrangements so your family can share the Hale experience. The program is open to all families of any race, color, religion, or socioeconomic background.

Where Does The Money Come From?

Hale's financial aid money comes from Hale Funds and annual gifts from individuals and corporations. It is expected that the family will pay a part of the tuition, within their means.

The Application Process

Applications are submitted anonymously to our Financial Aid Committee. The group allocates tuition discounts to families based on need. The Committee is made up of current Hale staff and members of the Board of Directors. Their work can be very challenging and painstaking. They attempt to meet reasonable requests with the limited funds that are available. It is expected that the family will pay a part of the tuition. It is regrettable, but the committee may not be able to meet all the requests for assistance. **The attached FA application, along with a camp registration packet must be completed and submitted with a \$100 deposit by March 1, 2018. No late applications will be accepted.**

The Camp Director and their FA committee are the only people who see the application with your name attached to it. The Directors submit the applications without identifying the individual applicants' names on the forms. You will be contacted regarding the status of your application by April 1, 2018.

- Applications for FA will not be considered **until all bills from previous years are paid.**
- Families must decide whether to accept the awarded financial aid prior to May 1st, at which point the \$100 deposit becomes non-refundable and applied to your camp fees.
- Once Financial Aid decisions have been made, recipients may pay with a payment plan.
- A registration form for HDC must also be filled out and received with the request.
- Financial Aid does not apply to Hale Day Camp Session 5 or Extended Day.

We realize that this application process is lengthy and involved. Hale invests a lot of time and effort into all of our families and campers and we appreciate your time in completing these forms.
